**ORDER:-**

In the G.O. first read above Government framed rules known as the Andhra Pradesh Municipal Corporation (Reservation of Seats) Rules, 1995 and these rules provide the manner in which for reservation of seats, its rotation and order of reservation for wards of Municipal Corporations in the State of Andhra Pradesh.

2. In the G.O second read above Government dispensed the system of drawal of lots for Reservation of Seats to Backward Classes and adopted as that "after arriving at the wards proposed to be reserved for Scheduled Tribes, Scheduled Castes; in different wards in a Municipal Corporation the seats to be reserved for Backward Classes in the remaining wards in the Municipal Corporation shall be on rotation basis with reference to the largest percentage of voters of the said category to the total number of voters of the ward in the Municipal Corporation concerned in the descending order" and accordingly amended the Rule 10 of the Rules issued in the G.O first read above.
3. In the letter third read above the Commissioner MCH has furnished the guidelines for identification of B.C. Voters as per the amended Rule 10 of the rules issued in the reference second read above.
4. Government after careful consideration of the proposal of Commissioner Municipal Corporation of Hyderabad issue the guidelines for Identification of Backward Classes Voters appended to this order, in order to follow the amended Rule 10 of Andhra Pradesh Municipal Corporation (Reservation of Seats) Rules, 1995 issued in the G.O second read above.
5. The Commissioner, Municipal Corporation of Hyderabad shall take necessary further action accordingly.
