The Government of India (hereinafter called "Borrower") has received financing from the International Bank for Reconstruction and Development (IBRD) in the form of loan (hereinafter called "loan") towards the cost of Telangana Municipal Development Project [TMDP]. The Commissioner and Director of Municipal Administration, MA&UD Dept., Govt. of Telangana, an implementing agency of the Client, intends to apply a portion of the proceeds for consulting services.

The consulting services ("the Services"): Preparation of DPR on Urban Green Environment Project in 72 ULBs of Telangana State which includes following components:

- a. Site identification such as Open space for Tree parks ó Site suitable for Tree Parks
- b. Developing of complete parks - Site suitable for complete Parks (more than 0.5 Acres)
- c. Developing of Children Parks - Site suitable for Children Parks (less than 0.5 Acre).
- d. Developing Smruthivanams - Site suitable for Smruthivanam (below 1 Acre)
- e. Developing of Avenues / Rotary / Medians - Site suitable for Rotary / Medians:

The above components are to be taken up as parallel activities as completion of one component is not contingent upon the other component. However, the planning and implementation is to be done keeping in view the project requirements as a whole and the outputs are to be integrated based on requirements.

The implementation period is **3 months**.

The Client now invites eligible consulting firms (‘Consultants’) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (Brochures, description of similar assignment, experience in similar conditions, availability of appropriate skills among staff etc.).

The short listing criteria are:

- (i) Annual Turnover = **Rs.1.50 Cr.**
- (ii) The firm shall be in the core business of Preparation of DPRs for Parks in Urban areas during the last **five (5)** years.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank’s *Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers*, January 2011 revised July 2014 (‘Consultant Guidelines’), setting forth the World Bank’s policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. In case any firm wishes to associate with another firm, it should inform in their Expression of Interest about the nature of association whether as joint venture or as sub-consultant.

A Consultant will be selected in accordance with the ‘Selection Based on Least cost selection’ (LCS) method set out in the World Bank’s guidelines selection and employment of consultants by World Bank borrowers, January 2011 revised July 2014.
