The attention of the Municipal Commissioners noted in the address entry is invited to the reference cited. Wherein it is informed to submit the Annual Development Plans for the year 2015-16 for the following core areas:

- i. SWM Activities
- ii. Development of Burial Grounds
- iii. Development of Vegetable markets
- iv. Development of Non-Veg. Markets
- v. Construction of compound wall to open spaces
- vi. Development/Construction of Slaughter houses
- vii. Development of Junctions, Medians
- viii. Street Lighting not exceeding 10%
- ix. Development of Parks
- x. Gaps in Water supply distribution lines not exceeding 10%
- xi. Viability gap funding for any PPP mode
- xii. Road works not exceeding 20%
- xiii. IT related Services

2. However, in view of revised guidelines the ADPs may be proposed for the following components:

A. Basic Services (Not exceeding 70%)

- i. Drinking water supply
- ii. Street Lighting
- iii. Road works
- iv. Drains

B. Other Infrastructure

- i. SWM Activities
- ii. Development of Burial Grounds
- iii. Development of Vegetable markets
- iv. Development of Non-Veg. Markets
- v. Construction of compound wall to open spaces
- vi. Development/Construction of Slaughter houses
- vii. Development of Junctions, Medians and parks
- viii. Viability gap funding for any PPP mode
- ix. IT related Services

Therefore, the Municipal Commissioners noted in the address entry are instructed to prepare the ADPs along with the Municipal Council resolution as per the components given above and submit the proposals to this office through Regional Level Committee without delay. They are further instructed to give priority to the works identified during Mana Vooru - Mana Ward- Mana Pranalika programme.


