The Government of India (hereinafter called "Borrower") has received financing from the International Bank for Reconstruction and Development (IBRD) in the form of loan (hereinafter called "loan") towards the cost of Andhra Pradesh & Telangana Municipal Development Project [APTMDP]. The Director of Municipal Administration, MA&UD Dept., Govt. of Telangana, an implementing agency of the Client, intends to apply a portion of the proceeds to the above consulting services.

The implementation period is **6 months**.

The Client now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services for **Unique Smart Addressing Solution for Urban Dwellings (USASUD) in GHMC area** and also provide the necessary application to integrate into the E-governance modules. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The short listing criteria are:

1. The firm shall be registered Company in India as per Indian Companies Act, 1956/2013 or Globally registered firm with respective country's registration requirement. Documentary proof for the same shall be submitted in the EOI.

2. The Firm shall have an average turnover of Rs.74 Crores or USD 11.40 Million during the last three (3) FYs.

3. The firm shall have an experience of implementing a GIS based Unique Smart Addressing Solution for the Urban Dwellings (USASUD) or house numbering project for Urban Local Bodies with 40000 properties in each of the 5 towns or 200000 in single town.

4. The firm shall have implemented an integration with at least one or more existing E-Governance application or any other Public platforms.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers, January 2011 revised July 2014 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture/consortium or a sub-consultancy to enhance their qualifications. In case any firm wishes to associate with another firm, it should inform in their Expression of Interest about the nature of association whether as joint venture/consortium or as sub-consultant.

A Consultant will be selected in accordance with the "**Quality and Cost Based Selection (QCBS)**" method set out in the Consultant Guidelines.
