The Government of India (hereinafter called " Borrower ") has received financing from the International Bank for Reconstruction and Development (IBRD) in the form of loan (hereinafter called "loan") towards the cost of Telangana Municipal Development Project [TMDP]. The Director of Municipal Administration, MA&UD Dept., Govt. of Telangana, an implementing agency of the Client, intends to apply a portion of the proceeds to the above consulting services.

The implementation period is **6 months (for each package)**.

The Client now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The short listing criteria are:

(i) Annual Turnover during the last 3 FYs(for each package) = **Rs.6.00 Cr.**

(ii) The firm shall be in the core business of preparation of DPRs for Strom Water and Under Ground Drainage during the last **ten (10) years**.

(iii) The firm shall have successfully completed atleast **2 similar assignments** in Strom Water and Under Ground Drainage for Govt/ULB during the last **10 years**.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers, January 2011 revised July 2014 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. In case any firm wishes to associate with another firm, it should inform in their Expression of Interest about the nature of association whether as joint venture or as sub-consultant.

A Consultant will be selected in accordance with the "**Least Cost Selection (LCS)**" method set out in the Consultant Guidelines.
