DESCRIPTION OF WARD BOUNDARIES

Ward No.	Description
1	North: The Northern boundary starts from Sy.No.33 of Bornapally (RV) at Karimnagar Road and proceeds towards the northern side up to Sy.No.82 at hillock and turn right side and Proceeds towards Eastern si2-158/de up to Sy. No. 88 Bornapally village .
	East: The Eastern boundary Starts from Kothapally Agriculture fields and ends at Nagendra Swamy Temple
	South: The Southern boundary Starts from Nagendra swamy Temple and ends To end at G.P. Road, Kothapally , Via DBM 16 canal
	West: The Western boundary Starts from G.P. Road Kottapally DBM 16 canal and proceeds up to Karimnagar main road and turns towards northern sides then proceeds along the karimnagar Road, ends at Sy.No.33 of Bornapally (RV)
2	North: The Northern boundary Starts from Ganesh Nagar Localities to Sai Garden.
	East : The Eastern boundary Starts from SAi Garden to Along the Jammikunta Road & ends at Maadhu takies opp Road
	South : The southern boundary Starts from Madhu takies Opp Road to Model Cheruvu and end at Ganesh nagar Agriculture lands.
	West: The Western boundary starts from Ganesh Nagar Agriculture lands , Ganesh nagar locality
3	North: The Northern boundary Starts from Gannarapu Swamy H. No. 5-151 & runs towards the South upto Sy. No. 72, H. No. 5-147/2 of Kokkisa Rama.
	East:The Eastern boundary Starts from Ramidi Rajireddy H. No. 3-206 runs towards West upto Sy. No. 548, H. No. 4-1 of Kasula Ravindra Chary.
	South: he Southern boundary Starts from Kasula Ravindra Chary H. No. 4-1 & runs towards North
	West: The Western boundary Starts from Jammikunta Road Banala Sadanandam H. No. 15-107 runs towards East upto Sy. No. 2521 H. No. 5-151 of Gannarapu Swamy
4	North: The Nothern boundary Starts from H.No. 3-159 then ends at Harihara rao open well
	East: he Eastern boundary Starts from Harihara rao open well to proceeds to the agriculture field and ends at masid at prathapa wada
	South:The Southern boundary Starts from Masid in prathapa wada proceed up to H.No. 3-54-1 and then take right ends at H.No. 3-42
	West: The Western boundary Starts from H.No. 3-42 ends at H.No. 3-160(Ram gopal rice mill Junction)
