SOUTH	Start from Madiga Kunta and turned at Gandhi Statue to Left Side and again turned at Gayathri Bank Street and ends at Laxmi Garden .
WEST	Start From Laxmi Garden goes towards North and end at SRSP Canal Near Sy.No:577.

NORTH	Starts from SimhaRaju Shankaraiah House(2-40/15/C/1) and goes towards East Japa Lingareddy House Bearing the House No.2-37
EAST	Starts Japa Lingareddy House Bearing the House No.2-37 from goes towards South side Shivaji Raithu Sangham
SOUTH	Starts from Shivaji Raithu Sangham and goes towards West Side Markendeya Temple
WEST	Starts from Markendeya Temple goes towards North Side SimhaRaju Shankaraiah

NORTH	Starts from Bapurapu Pochaiah House No.1-68 and goes towards and ends at East Side Abdul Nabi House No. 1-1
EAST	Starts from Abdul Nabi House No. 1-1 and goes towards South Side and ends at MPDO Office
SOUTH	Starts from MPDO Office and ands goes towards west side and ends at Ippakayala Narsingam bearing the House No:
WEST	Starts from Ippakayala Narsingam bearing the House No. goes towards North Side Bapurapu Pochaiah House No.1-68

NORTH	Starts from Gutta Laxmibai House No.26-1 goes towards East Side and ends at Joga Gangarajam Bearing the House No:26-63/B
EAST	Starts from Joga Gangarajam Bearing the House No. goes towards South Side and ends at Vadlakonda Bearing the House No.25-9.
SOUTH	Starts from Abdul Khalik Bearing the House No.25-1. goes towards West Side Mahammad Khajamoddin Bearing the House No.25-72/1.
WEST	Starts from Mahammad Khajamoddin Bearing the House No.25-72/1.and goes towards North side and ends at Gutta Laxmibai House No.26-1
