**DESCRIPTION OF WARD BOUNDARIES**

<b>WARD NO- 1</b>
<p><b>NORTH:-</b> Naspur village north boundary.</p> <p><b>EAST :-</b> A line starts from Radiant High school road run towards north side through vegetable market road ends at CCC township road then move towards east side upto ccc police station west side compound wall road move through the road upto mukkidipochamma temple then turn to east side upto ccc plant road then move to north side upto polytechnic collage road then move to east side upto railway track then move to north side ends at Naspur Municipality north side boundary.</p> <p><b>SOUTH:-</b> A line starts from Road opposite Radiant High school move towards west side ends at Water tank near Venkateshwara temple in shirkey quarters.</p> <p><b>WEST:-</b> A line starts from Water tank near Venkateshwara temple in shirkey colony run towards north side upto Nandanavanam Park ends at Naspur boundary.</p>
<b>WARD NO- 2</b>
<p><b>NORTH:-</b> Naspur North side boundary.</p> <p><b>EAST :-</b> A line start from north side boundary of Naspur to move towards south side upto Nala in Sangamallaiahpalli. and move to Nala ends at Sy.No.31 of Thigalapahad shivar.</p> <p><b>SOUTH:-</b> A line start from center point of Nala in Sangamallaiahpally move towards west side through Nala upto Sy.No.31 of Thigalapahad shivar then move towards north side upto ccc police station road.</p> <p><b>WEST:-</b> A line start from west side road of ccc police station at ccc town ship road move towards north side and ends at Naspur north side boundary.</p>
<b>WARD NO- 3</b>
<p><b>NORTH:-</b>Thallapalli north side boundary.</p> <p><b>EAST :-</b> A line starts fromThallaplli village north-east corner to run towards south side through thallapalli boundary uptosingapur boundary then run towards west side upto Mandamarri to Godavarikhani road then cross the GDK road upto Sidhi Vinayaka Ganesh mandali then move towards south-east corner upto Friday market road.</p> <p><b>SOUTH:-</b>Aline stars from Friday market to Railway under bridge in SRP-1 Mine.</p> <p><b>WEST:-</b>Aline stars fromRailway under bridge in SRP-1 Mine to Thallapalli shivar north-east corner through railway track.</p>
