DESCRIPTION OF WARD BOUNDARIES

Ward No. 1

- North: - Its starts from korutla Municipal limits bearing Sy.no.465 on kallur road and proceeding towards Eastern side along the Municipal boundary and joins the bearing Sy.No.466.
- East: - Its starts from korutla Municipal limits bearing Sy.no.466 and proceeding towards Southern side through Renuka Ellamma Devalayam bearing H.no.1-1-950/9/142/3 and crossed the railway track through bearing H.No.1-1-871/1/1 and proceeding towards Southern side in a zigzag manner and joined bearing H.No.1-1-862/1.
- South:- It's starts from bearing H.No.1-1-862/1 and proceeding towards western side and joined bearing H.No.1-1-902/3 on Kallur road.
- West:- It's starts from bearing H.No.1-1-902/3 and proceeding towards Northern side along with the Kallur road and crosses the railway track and Joined the Municipal limits bearing Sy.No.465.

Ward No. 2

- North: - It starts from bearing Sy.No.466 on the Municipal boundary and proceeding towards Eastern Side along with Municipal boundary and joins bearing Sy.No.515 at the Vaagu.
- East: - It Starts from House bearing Sy.No.515 at Vaagu and proceeding towards Southern side along the Vaagu boundary and joins bearing H.No. 1-1-2.
- South:- It Start from NH-63 R&B Road, H.No.1-1-2 towards Western Side all along the NH-63 R&B Road and joined at building bearing H. No.1-1-22 and proceeding towards North West direction and joins H.no1-1-84/5.
- West:- It Starts from building House bearing No. 1-1-84/5 and proceedings towards Northern side through 1-1-154/1/1 and proceeding towards Northern side along the drain boundary and joins Municipal boundary at Sy.No.466

Ward No. 3

- North: - It Starts at Telangana Thalli statue on NH 63 main road and proceeding towards Eastern side along NH 63 and 5-3-162/4 and proceeding towards Northern side along the Vaagu boundary and joins the Municipal limits at bearing Sy.No.515 at the Vaagu and proceeding towards Eastern side along the Municipal boundary and joins bearing Sy.No.770.
- East: - It Starts from Sy.no.770 at Municipal boundary and proceeding towards Southern side along with the Municipal boundary through Polytechnic College and proceeding towards Southern side along with the Municipal boundary and joined the Sy.No.847 at Municipal limits.
- South:- It Starts from Sy.No.847 at Municipal boundary and proceeding towards Western side along Municipal boundary and joins bearing Sy.No.884 and proceeding s towards Northern side and joins bearing H.No.5-3-162/1, 5-3-146, 5-3-203, 5-3-216 and proceeding towards in a zigzag manner and joined bearing H.No.5-3-1, 5-2-518
- West:- It starts from bearing H.No.5-2-518 and proceeding towards Northern side and joins bearing H.No.5-3-83 and proceeding towards Eastern side
