

**DESCRIPTION OF WARD BOUNDARIES**

<b>WARD No. 01</b>	
<b>North</b>	Starts from Sy.no. 15 in Northern direction on Municipal boundary to move in Eastern direction along the Municipal boundary till reach the Railway Line.
<b>East</b>	Starts from the Northern most point for Railway line in the Municipal Boundary along the Railway line till Reaches Railway Quarters Road junction.
<b>South</b>	Starts from Railway Railway Quarters Road junction to move in Western direction Garla Road - Ambedkar Nagar Junction and continue till Junction at Bokkalakottu and Ambedkar Nagar localities meets.
<b>West</b>	Start from Bokkalakottu and Ambedkar Nagar localities Junction area to proceed in Northern direction along Ambedkar Nagar border till sy.no. 15 which is northern most Municipal Boundary and the initial Point.
<b>North</b>	Starts from Sy.no. 15 in Northern direction on Municipal boundary to move in Eastern direction along the Municipal boundary till reach the Railway Line.
<b>WARD No 02</b>	
<b>North</b>	Starting from North point on Railway Line (Kazipet - Vijayawada) Sy.No. 26, move towards Eastern side passing through DD High School, Junior College Building, and beside Deaf and Dumb, Girls Hostel Sy.No. 34, beside Hill Rock, and Grave Yard (Sy.No. 36), pass through Sy.Nos. 50, 58/1 till Reaches Sy.no. 45 on Municipal Boundary.
<b>East</b>	From Previous sy. No 45 along the Municipal Boundary turned right in South direction - and along Municipal Bondary meets sy.no. 54 duly covering the areas Bishop compound, Jayapuram, Keerithapuram, and Part of New Nehru Street.
<b>South</b>	Starting from the part of New Nehru Street road adjust to the railway track meet the boundary of bankatsingh thanda duly covering the total area of keeritapuram hill rock area and grave yard sy.no.36 deaf and dum school kashuri baa girls hostel and meet DD high school, junior college building and meet railway line.
<b>West</b>	Starting from previous junction moving towards North direction having Railway line as Western Bondary - Continue pass though New Nehru Street till reaches Sy.No. 26 adjcent to Railway line.
<b>WARD No 03</b>	
<b>North</b>	Starting from the location of Garla kumra beside and moves beside area of Keeritapuram with covering total area of Bankatsingh Thanda and reach yeeramatti thanda.
<b>East</b>	From Previous Sy. No 45 along the Municipal Boundary turned right in South direction - Arrived Erramatti Thanda and along Municipal Bondary meets sy.no. 51 & 52 Point.
<b>South</b>	Starting from and passed two wards east of municipal boundary met to over to

	covering total area of Tranku Thanda end at start point of New Nehru street
<b>West</b>	Starting from the boundary of keeritapuram and New Nehru Street and moves two wards east side of municipal boundary end point with covering tranku thanda. Yeeramatti Thanda.
<b>WARD No 04</b>	
<b>North</b>	Starting from Part of New Nehru Street locality, North point Sy.no. 78 junction (Junction Point of KZJ -BZA-KGM Railway line) move towards Eastern side along Railway line Sy.No. 85 to Sy.No. 88 till raches Municipal Boundary in Eastern along Railway Line.
<b>South - East</b>	Starting from Eastern Municipal Boundary Point Sy.No. 88 move in South- West direction covering the Signal Thanda along Railway Boundary till the Railway line at Sy.No. 81
<b>West</b>	Starting from the Sy.No. 81 and keep Railway line to be border in left hand side and continue in North direction till reaches the earlier starting point i.e., Sy.no. 78 junction (Junction Point of KZJ -BZA-KGM Railway line).
<b>WARD No 05</b>	
<b>North</b>	Starting from the the Railway line at Sy.No. 81 continue along Railway Line till the End Point of Municipal Boundary at Yellandu Railway line.
<b>East</b>	Starting from the End Point of Municipal Boundary at in Sy.No. 88, continue along the municipapal boundary passes through Khammam High Way - Lachya Thanda, and following along the boundary till reaches the Vijayawada Railway Line.
<b>South</b>	Starting from South most point of Municipal Boundary in Sy.No. 105 to move in North - West direction along the Boundary till Sy.No. 107 then after slight left in Western direction upto Sy.No. 114 - take another left and continue along boundary till Sy.No. 157 duly passing Raju Thanda - and follow the Sy.No. 157 pattern and reach the junction point of Ammapalem Road and Sy.No. 157 & 158
<b>West</b>	From the Junction point of Sy.No. 158 and Ammapalem Road - Move in Northern direction along Ammapalem road till reaches the Sy.No. 296, meet Main Road Petrol Pump, Sy.no 296, , 167 and goes through bund road upto sy.no.114, Take left turn towards Eastern side till Jagjeevanram Junction to meet the initial Point Fly-over landing point at SC-BC Colony .
<b>WARD No 06</b>	
<b>North -East</b>	Starting from Bharat Petrol Pump Junction, continue along Main Road through, MRO, MDO Office Junction, and the turn left move in Northern direction till reaches Muslim Grave Yard in Sy.No. 137, and then after Take Right and continue till reaches Subhash Street Main Road, and then move in Southern direction till Sai Baba Temple Junction, and then to follow along Main Road to Reach Railway Line in Sy.No. 127.
<b>South - West</b>	Starting from Sy.No. 127 on Railway Line, continue till Sy. No. 118 on Railway Line and then turn Right and move in South-West Direction, through, Sy.No's 117, 111, and Pass through, SC-BC Colony, and to meet Area Hospital beside Sy.No. 54, and continue along the Tank Bund, passing through Sy.No's 162, 167, and till reaches Main Road at Bharat Petrol Pump Junction

<b>WARD No 07</b>	
<b>North</b>	Starting from the Subhash street locality covering H.No's 2-3-1 to 2-3-43, beside 4 <sup>th</sup> Main Road, reaches the Railway Line
<b>East</b>	Keeping Railway Line as boundary till Sy.No. 127 on Railway Line.
<b>South - West</b>	Starting from opposite to Muslim Grave Yard in Sy.No. 137, and then after Take Right and continue till reaches Subhash Street Main Road, and then move in Southern direction till Sai Baba Temple Junction, and then to follow along Main Road to Reach Railway Line in Sy.No. 127 duly covering the locality Subhash street H.No.'s 2-2-60 to 2-2-148..
<b>WARD No 08</b>	
<b>North</b>	Starting from Masjid Junction on Main Road - continue along the Main Road till Reaches the Railway Station.
<b>East</b>	Starting from the Railway Station - passes through 4 <sup>th</sup> Man Road - continue along Post office Main Road till reaches Muslim Grave yard,
<b>South</b>	Starting from Bank street Main Road - continue till Veternery Hospital Junction, duly covering the Bapuji Nagar Part.
<b>West</b>	Starting from Bank street Main Road, passes through Mangali Bazar and reaches Masjid Junction.
<b>WARD No 09</b>	
<b>North</b>	Starting from Bank street Main Road - continue till Veternery Hospital Junction, duly covering the Bapuji Nagar Part.
<b>East</b>	Starting from Verternary Hospital Junction to reach MRO, MDO Office Junction on By-Pass Road
<b>South</b>	Starting from Bharat Petrol Pump Kunction on Mahabubabad By-Pass Road continue along through Main Road til reaches MRO, MDO Office Junction
<b>West</b>	Starting from the Bharat Petrol Pump Junction on Mahabubabad By-Pass Road continue along the bank Street Main Road to reach the Initial Starting point on north.
<b>WARD No 10</b>	
<b>North</b>	Starting from the Northern point of the locality covers by Rajiv Nagar, Kundoju Vaari Veedi, reaches Masjid Junction.
<b>East</b>	Starting from the Masjid Junction on Main road, continue along the Bank street Main Road till reaches the Bharath Petrol Pump junction on the Mahabubabad Road.
<b>South</b>	From the Bharath Petrol Pump junction point on the Mahabubabad Road - continue along the Main Road till Primary School.
<b>West</b>	Starting beside Primary School, continue along Sy. No.'s 305, 320, and covers the Yadav Nagar-1 Part 5-1-1 to 5-1-73/1.

<b>WARD No 11</b>	
<b>N,E,S,W</b>	Starting from the Northern Direction of the Locality Yadav Nagar-1, covering 5-1-74 to 5-1-173 in clockwise direction duly following the Geographical continuity.
<b>WARD No 12</b>	
<b>N, E, S,W</b>	Starting from the Northern Direction of the Locality Yadav Nagar-1, covering 5-1-174 to 5-1-308 and location Yadav Nagar-2 covering 5-2-1 to 5-2-148 in clockwise direction duly following the Geographical continuity.
<b>WARD No 13</b>	
<b>N, E, S,W</b>	Starting from the Northern Direction of the Locality Yadav Nagar-2 covering 5-2-149 to 5-2-163 And Bokkala Kottu locality covering 6-1-1 to 6-1-55 in clockwise direction duly following the Geographical continuity.
<b>WARD NO.14</b>	
<b>N,E,S, W</b>	Starting from the Northern Direction of the Locality Bokkala kottu locality covering 6-1-56 to 6-1-111, Shastri Nagar covering H.No.6-1-112 to 6-1-197 and Shanthi Nagar covering H.No.3-2-11 to 3-2-134 in clock wise direction duly following the Geographical continuity.
<b>WARD NO. 15</b>	
<b>North - East</b>	Starting from the Location Shanthi Nagar beside Shastri Nagar area, continue through H. No's 3-1-1, upto 3-1-157.
<b>South-West</b>	Starting from the Location Shastri Nagar adjacent to Shanthi Nagar area, continue through H. No's 3-2-1, upto 3-2-110.
