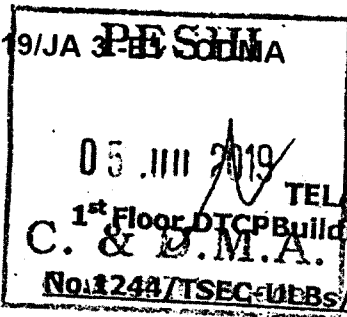

**NOTIFICATION**

In reference No.1244/TSEC-ULBs/2019, dated 03.07.2019, the State Election Commission issued notification for preparation and publication of ward wise photo electoral rolls of all Municipalities including Nakrekal Municipality in Nalgonda district and Badepally Municipality in Mahabubnagar district.

After issue of said notification, the Director of Municipal Administration and Election Authority in her Lr.Roc.No.115309/2019/Elec-2, dated 04.07.2019 informed that, as per the Act 4 of 2018, out of 131 Municipalities, Nakrekal Municipality shall be formed as Municipality after expiry of present term of elected body by December, 2020. Similarly, Jadcherla Gram Panchayat is merged into existing Badepally Municipality which is having elected body and its term will expire by December, 2020. In view of these reasons, she has requested the State Election Commission to exclude Nakrekal and Badepally Municipalities from the list appended to the notification No.1244/TSEC-ULBs/2019, dated 03.07.2019.

The Commission examined the matter and decided to delete Nakrekal and Badepally Municipalities from the list appended to the notification No.1244/TSEC-ULBs/2019, dated 03.07.2019 and issue an Errata accordingly.

Therefore, in exercise of the powers conferred under Articles 243- K and 243-ZA of the Constitution of India all others powers hereunto enabling, the Telangana State Election Commission hereby issues the following Errata to the Notification Issued in Ref. No.1244/TSEC-ULBs/2019, dated 03.07.2019.

**ERRATA**

In Annexure – I appended to the notification No.1244/TSEC-ULBs/2019, dated 03.07.2019 in Column No.3 at Sl.No.53 Nakrekal and at Sl.No.71 Badepally shall be deleted.
