Ref:- TSEC Circular No. 2452/TSEC-ULBs/2019, dated: 05.07.2019.

In the reference cited, the Commission issued schedule for publication of list of Polling Stations of 129 Municipalities.

As per the schedule indicated therein, the draft ward wise list of polling stations will be published on 12.07.2019 and final list of Polling Stations on 19.07.2019.

In the Political Parties meeting held on 08.07.2019 in the Office of State Election Commission in connection with the Ordinary Elections to ULBs, all the Political Parties stated that, tight schedule is given for publication of polling stations and requested to change the schedule by extending the dates for publication of polling stations.

The Commission examined the request made by the Political Parties and considered to revise the schedule for preparation and publication of polling stations of Municipalities.

In supersession of the schedule given in the reference cited, the following revised schedule is given for preparation and publication of ward wise polling stations of 129 Municipalities indicated in the reference cited.
