**ORDER:-**

In the references 1st and 5th read above, the State Election Commission has appointed the Commissioner & Director of Municipal Administration as Election Authority to exercise such powers and to perform such functions specified in the Telangana Municipalities Act and the rules made thereunder in connection with conduct of elections and also authorized the DMA to appoint Returning Officers and Assistant Returning Officers in all the Municipalities and Municipal Corporations in the State.

Accordingly, in the reference 6<sup>th</sup> read above, the District Collector, Rangareddy has submitted the proposals indicating revised names of certain Officers and staff for appointment as Returning Officers and Assistant Returning Officers including wards allotted to them in (06) Municipalities viz., Turkayamjal, Adibatla, Tukuguda, Shadnagar, Shankarpally, Jalpally Municipalities and (03) Corporations viz., Meerpet and Bandlaguda-Jagir and Badangpet in Rangareddy District.

In view of the above and in partial modification to the orders issued vide references 2<sup>nd</sup> and 4th read above and in exercise of the powers delegated by State Election Commission vide references 1<sup>st</sup> & 5<sup>th</sup> read above, the Director of Municipal Administration and Election Authority hereby authorize the appointment of certain revised Returning Officers and Assistant Returning Officers in (06) Municipalities viz., Turkayamjal, Adibatla, Tukuguda, Shadnagar, Shankarpally, Jalpally Municipalities and (03) Corporations viz., Meerpet and Bandlaguda-Jagir and Badangpet in Rangareddy District as per the list enclosed to this order.
