NORTH	:	Start from Sy.No.245 and proceeding towards East touching Sy.No.273/2 including forest area and ends at Sy.No.274 North upto Rajiv Gruha Kalpa Colony.
EAST	:	Start from 274 proceed along Ganesh Mandapam of Bhoodhan Colony and ends at Sy.No.81.
SOUTH	:	Starts from Sy. No.81 proceeds touching with Sy.No.80, 77, 76, 41, 75, 56, 45, 306, 307, 33, 32, 27, 220, 258, 240, 244, 236, 234 and 235 ends.
WEST	:	Start from Sy.No.235 along with Sy.No.225, 243 ends upto Sy.No.245.
WARD NO.2		
NORTH	:	Starts from Pasumamula Revenue village Sy.No.427 to towards East side touching Sy.No. 429, 53, 82 and 93.
EAST	:	Starts from Sy.No.93 proceeds towards South side touching Sy.No.101, 102, 104, 173 and 174 upto ring road.
SOUTH	:	Starts from Sy.No.137 ring road proceeds towards west side adjacent Sreetharama Chandra Swamy Temple touching Sy.No.178, 250, 254, 264, 311 and H.No.2-38, ZP road to H.No.2-51/1 of Old village upto Edamma Gudi Sy.No.454, 452, 450 and upto Sy.No.415 of Pasumamula boundary.
WEST	:	Starts from Sy.No.415 of Pasumamula boundary arch proceed towards North side touching Sy.No.420, 421, 422, 423 and upto Sy.No.427.
WARD NO.3		
NORTH	:	Starts from Sy.No.413 Pasumamula arch proceeds towards East touching Sy.Nos. 412, 411, 357, 356, and 355 Sai Vihar Colony, BBR Colony to Old village part Gouda Sangam H.No.1-13/3 and 2-8, 1-7/12, 1-8/6/1 crossing ZP road to Sy.No.354, 345, 316, 249 along ring road upto Sy.No.180.
