1	NORTH	Starts from Mye Villas boundary and proceeds towards East along FCI Godown Road and ends at junction of FCI Godown Road and chengicherla Rd.
	EAST	Starts from junction of FCI Godown Road and chengicherla Rd, and proceeds towards south all along the Chengicherla main road and ends at H P Petrol Bunk
	SOUTH	Starts from H P Petrol Bunk and proceeds towards west along along Pochama Cheruv Bund and cuves at chengicherla ward office ends at Previllage.
	WEST	Starts from south- corner of previllage and goes towards North side all along the boundary of chengicherla Survey no, 76 and ends at Mye Villas
2	NORTH	Starts from H.no.5-2-392 and proceeds towards East all along the Municipal boundary and ends at Sy.No.23 of Chengicherla.
	EAST	Starts from Sy.No.23 of Chengicherla.and proceeds towards south all along the Municipal boundary and ends at Sy.No.58 of Chengicherla.
	SOUTH	Starts from Sy.No.58 of Chengicherla.and proceeds towards west all along the Municipal boundary and ends at Ranga rangaya Nagar Sy.No.64 of Chengicherla.
	WEST	Starts from Ranga rangaya Nagar Sy.No.64 of Chengicherla. and goes towards North side all along the Chengicherla Main Rd, and ends at H.no.5-2-392.
3	NORTH	Starts from H.no.4-7-3 and proceeds towards East all along the chengicherla ward office Rd. and curves along Pochama Cheruv Bund and ends at H.No.2-68/50/1.
	EAST	Starts from H.No.2-68/50/1 and proceeds towards south all along the Chengicherla Main Rd, and ends at H.No.4-64/67
	SOUTH	Starts from H.No.4-64/67 and proceeds towards west all along the Municipal boundary and ends at H.no.1-4-24.
	WEST	Starts from H.no.1-4-24. and goes towards North side all along the boundry of Sy.No.75 & 76 of Chengicherla and ends at H.no.4-7-3.
4	NORTH	Starts from H.no. 2-124/74/14/1 and proceeds towards East all along the chengicherla Rd. and ends at H.No.4-7-3.
	EAST	Starts from H.No.4-7-3 and proceeds towards south all along the boundary of Sy.No. 82, 84, 85, 86 & 92 of Boduppall and ends at Plot No. 35 & 36 NIN colony.
	SOUTH	Starts from Plot No. 35 & 36 NIN colony. and proceeds towards west and ends at Plot No. 6 NIN colony.
