WARD - 1	
NORTH	Starts from Survey No.369 and goes towards east and ends at Sy no.416
EAST	Starts from Sy.No.416 and goes NKS Mogalicheruvu water tank road Which joints to Kupkal Road
SOUTH	Starts from Mogalicheruvu water tank road and ends at H.No.13-112/6/1 of Mulka Gangadhar
WEST	Starts from H.No.13-112/6/1 of Mulka Gangadhar house and goes towards sumangali junction (H.No.14-1/1) of Sayyad Samiulla house and by covering municipal office junction ends at Sy.No.369)
WARD - 2	
NORTH	Starts from Survey no.416 and goes towards east and ends at Sy No.503
EAST	Starts from Sy.No.503 and goes towards South by covering Sy No.513, 545 and 554 and ends at Sy No.611.
SOUTH	Starts from Sy.No.611 to and ends at house no.2-43/3 of Beeruvala Ganesh and by taking right goes towards Muchkur junction (H.No.1-3/15/B of P Prabhakar and by taking left ends at sumangali Junction (H.No.14-16 of Sundharaiah)
WEST	Starts from House No.14-16 of Sundharaiah at sumangali junction and goes towards H.No. 13-125/3 of Thota Renuka and goes towards Mogalicheruvu water tank road by taking left ends at Sy.No.416
WARD - 3	
NORTH	Starts from H. No. 2-43/1/A of P Jyothi and goes towards Sy.No.612 and by covering Sy.No.836 and 864, 808 and ends at Sy.No.882.
EAST	Starts from Sy.No.882 and by covering Sy.No.895, 897, 964 and ends at Sy.No.1255
SOUTH	Starts from Sy.No.1255 and goes towards Bejjora Bypass first Road and by taking first right goes towards H.No.2-88/1 of Mutha Bangaram House and H No.3-46 of Mutha Nasru
WEST	Starts from H No. 3-46 of Mutha Nasru and goes towards H No. 2-54/3 of Puppala Jagadeesh and by taking left ends at H. No 2-43/1/A of P Jyothi.
WARD - 4	
NORTH	Start from Sy. no. 1235 and goes towards Bejjora baipass second road and goes towards ZPHS girls School goes towards Boigally Hanmandlu and goes towards H.No. 6-24/1 of Beldari Poshetty and then taking left curve and ends at padma shali sangam.
