BHONGIR MUNICIPALITY :: DISTRICT YADADRI-BHONGIR	
DESCRIPTION OF WARD BOUNDARIES	
<u>WARD NO 1</u>	
NORTH	It starts from Sy No.1019 of Bhongir Revenue Village at Municipal limits and which moves all along the Sy No. 259/1, 254 Part ,252 Part moves in Eastern direction all along the municipal boundary up to north east corner of Sy No.251 of Bhongir Revenue Village.
EAST	It Starts form Railway Track at Sy No. 247 of Bhongir Revenue Village at Municipal Limits and Moves towards South East Direction all along the Railway Track through Sy No. 256, 258, 1025 which passes through Ambedkar Nagar H.No: 1-1-1/a/1 in South West Direction and ends at H.No: 1-1-49.
SOUTH	It Starts at H.No: 1-1-49 and moves through Ambedkar Community Hall and then it moves along all the way and truns left at H.No: 1-1-66/81 which moves all along the way and turn Right at H.No: 1-1-66/933 which moves all along the way and turns left at Dharmawaram Orbitorium Compound Wall and all along the Compound Wall.
WEST	It Starts at Husainabad to Baswapuram Road all along the Compound Wall of Dharmawaram Orbitorium and turn towards north direction at Sy.No:1081 and Passes through Sy.No.1077 and Ends at Sy.No: 1019.
<u>WARD NO 2</u>	
NORTH	It Starts form Railway Track at Sy No.247 of Bhongir Revenue Village at Municipal Boundary and Moves along the railway track and turns East all along the Baswapur Canal till Incredible India layout Main Road.
EAST	It Starts at Incredible India Main Road at Sy.No:762 and moves along South direction till Bhongir - Warangal Road and move all along the Raigiri Road and turns South towards Bypass Road (NH-163) which moves all along NH-163 till Vivera Hotel.
