

SOUTH	Starts from H.No. 5-58 goes along with Avusulapally village Road ends at H.No. 2-8.
WEST	Starts from H.No. 2-8 goes along with Avusulapally village Road ends at H.No. 4-69.
WARD 02	
NORTH	Starts from H.No. 4-47 goes along with Avusulapally village Road ends at H.No. 5-59.
EAST	Starts from H.No.2-10 goes along with Avusulapally village Road ends at H.No. 3-6.
SOUTH	Starts from H.No. 5-59 goes along with Avusulapally village Road ends at H.No.2-10.
WEST	Starts from H.No.3-6 goes along with Avusulapally village Road ends at H.No.4-47.
WARD 03	
NORTH	Starts from H.No. 5-47 goes along with Avusulapally village Road ends at H.No. 5-46.
EAST	Starts from H.No. 5-46 along with existing Municipal Limit and ends at Railway Track.
