2. The Secretary State Election Commission has stated that in the reference 1<sup>st</sup> cited the CEO, GAD has fixed the uniform rates for remuneration to be paid to the officers / officials drafted for General Elections to Telangana Legislative Assembly, 2018. The same was adopted by the Government during conduct of elections to PRIs in 2019. Further, stated that their rate is equally applicable to the Police personnel actually deployed to polling booths/counting and also to the staff for attending training classes, collecting polling material etc., and for attending duty on the polling day/ counting day.

3. Further, they have requested to issue orders fixing TA/DA remuneration to the employees drafted for ULB elections in the following manner.

8	Video Surveillance Team, Video viewing Team, Accounting Team, Expenditure Monitoring Control Room and Call centre staffs, Media certification and Monitoring Committee, Flying Squads, Static surveillance Team, Expenditure Monitoring Cell	Class - I/II- Rs.1200/- Lump sum Class-III- Rs.1000/- Lump sum Class-IV- Rs.200/-per day.
9	Student Volunteer (Web casting)	Rs.1000/- Lump Sum

10	Class IV	200/- per day or part thereof
11	Packed lunch and / or light refreshment	150/- per head per day

Therefore, the Collector & District Election Authorities and Municipal Commissioner & Assistant District Election Authorities are hereby instructed to follow the above rates for making payments to the Officials deputed for elections duly meeting the expenditure from the Election funds released to the Municipalities.
