ORDER:-

In the reference 1st read above, the State Election Commission has appointed the Commissioner & Director of Municipal Administration as Election Authority to exercise such powers and to perform such functions specified in the Telangana Municipalities Act, 1965 and the rules made there under in connection with conduct of elections to all the Municipalities in the State.

In the reference 2nd read above, the State Election Commission, Hyderabad has requested all the Municipal Commissioners in the State to send proposals indicating names of suitable officers of the local Authority or the Government through the Collector and District Election Authority to the Election Authority (i.e., C&DMA) for appointment as Election Officers and Assistant Election Officers.

Accordingly, in the reference 3rd read above, the District Collector, Medchal-Malkajgiri has submitted the proposals indicating the names of Officers and staff for appointment as Election Officers and Assistant Election Officers including wards allotted to them in Dammaiguda, Nagaram, Pocharam, Ghatkesar, Thumkunta, Jawaharnagar, Nizampet, Kompally, Gundlapochampally, Boduppall, Peerzadiguda, Medchal and Dundigal Municipalities.

4. In the reference 4th read above, this office has issued orders authorizing to appoint the Election Officers and Assistant Election Officers in above said Municipalities.

5. Subsequently, in the reference 5th read above, the District Election Officer & District Election Authority, Medchal- Malkajgiri District has submitted revised proposals
