ORDER:-

In the reference 1st read above, the State Election Commission has appointed the Commissioner & Director of Municipal Administration as Election Authority to exercise such powers and to perform such functions specified in the Telangana Municipalities Act, 1965 and the rules made there under in connection with conduct of elections to all the Municipalities in the State.

In the reference 2nd read above, the State Election Commission, Hyderabad has requested all the Municipal Commissioners in the State to send proposals indicating names of suitable officers of the local Authority or the Government through the Collector and District Election Authority to the Election Authority (i.e., C&DMA) for appointment as Election Officers and Assistant Election Officers in the prescribed proforma by 05.07.2019.

3. Accordingly, in the reference 3rd read above, the District Collector, Nalgonda has submitted the proposals indicating the names of Officers and staff for appointment as Election Officers and Assistant Election Officers including wards allotted to them in Nalgonda, Miryalguda, Devarakonda, Chandur, Haliya, Chityala and Nandikonda Municipalities.

4. In view of the above and in exercise of the powers delegated by State Election Commission vide reference 1st read above, the Director of Municipal Administration and Election Authority hereby authorize the appointment of Election Officers and Assistant Election Officers in Nalgonda, Miryalguda, Devarakonda, Chandur, Haliya, Chityala and Nandikonda Municipalities as per the list enclosed to this order.
