The attention of all the Municipal Commissioners in the State are invited to the reference cited, As you are aware that the Hon'ble Minister for MA&UD, IT, I&C., during the meeting at Bhongiri Municipality on 2nd October 2020 has decided to give Pattana Pragathi Puraskaram 2020 awards to the ULBs in the month of February 2021 who does exceptional work towards urban infrastructure and service delivery in various categories and also released the scheme of Pattana Pragathi Puraskaram-2020.

2. Accordingly, a leaflet of Pattana Pragathi Puraskaram 2020 along with detailed scoring criteria for each component i.e., Haritha Haram, Vaikunta dhamma, Public Toilet, Markets, Solid Waste Collection, Waste Segregation, Solid Waste Processing, Certification of ODF+ & ODF++ and Model Indicators ect., was also communicated to all the Municipal Commissioners in the State for ready reference.

All the Municipal Commissioners are hereby instructed to do self assessment of the marks as per the categories under each component as per the scoring criteria duly taking 30.12.2020 as the cutoff date for all the components and communicate the documentation to the Special officer allotted to your ULB by 10.01.2021.

Further, the special Officers are hereby instructed to evaluate the self assessment submitted by the each Municipal Commissioner either by visiting the ULB or by the documentary evidence submitted by the Municipal Commissioner and submit the final evaluation sheet to Sri K. Phalgun Kumar, Deputy Director, O/o the C&DMA by 20.01.2021, so as to shortlist the ULBs for the Pattana Pragathi Awards before 30.01.2021.

5. Therefore, all the Municipal Commissioners are hereby instructed to complete the documentation of best practices along with allocation of scores under each component and

submit the same to the Special Officers concerned by 10.01.2021 for taking further action.
