The attention of all Municipal Commissioners of all Urban Local Bodies in the State (except GHMC) is invited to the references 1<sup>st</sup> to 4<sup>th</sup> cited and in order to utilization of funds collected under LRS Scheme in Urban Local Bodies, the Government vide reference 2<sup>nd</sup> cited while reiterating the orders issued in the reference 1<sup>st</sup> cited gave directed to utilize the balance LRS amount as per the guidelines issued in matter in consultation with the District Collectors concerned.

2. Further, In the reference 3<sup>rd</sup> cited, Government after careful examination of the matter hereby permit to utilize up to 70% of LRS funds for taking up City Level developmental works.

In view of the above and in partial modifications to the orders issued vide reference 4<sup>th</sup> cited, the Municipal Commissioners of all Municipalities and Municipal Corporations in the State (except GHMC) are directed to submit the proposals for utilization of LRS funds for taking up developmental activities as per the guidelines issued in the references 1<sup>st</sup> to 3<sup>rd</sup> cited to the District Collectors concerned along with Council Resolutions for their approvals.
