The attention of all the Municipal Commissioners in the State is invited to the references cited and they are informed that in the reference 1st cited, Government issued orders according permission to the Municipal Councils/ Corporations to sanction the works relating to PATTANA PRAGATHI GRANTS (State Matching Grant+Finance Commission grants) released. Among others, development of Crematoriums/ Vaikuntadamams is one of the admissible components and priority work to be taken up under Pattana Pragathi programme. In the reference 2nd cited, this office communicated the above Government orders to the Municipal Commissioners of all ULBs for immediate action.

- 2. Subsequently, in the reference 3rd cited, circular instructions were issued to the Municipal Commissioners of all ULBs in the State informing about the basic components to be taken up in every Vaikuntadhamam and additionalities as per the budget available with them and they were instructed to establish one Vaikuntadhamam @ 3-10 wards as per area and population of the Town/ City and to complete the same immediately. They were further directed to have atleast one Vaikunta Ratham for transportation of the deceased person and to maintain necessary documentation with before, during and after photographs.
- 3. In this regard, the Municipal Commissioners of all ULBs are informed once again that the progress of construction of Vaikuntadhamams/ Crematoriums is being reviewed by the Hon'ble Chief Minister and Hon'ble Minister for MA & UD Department in the review meetings wherein they have directed to speed up and complete construction of Vaikuntadhamams/ Crematoriums on saturation mode.
- 4. Therefore, the Municipal Commissioners of all ULBs are directed once again to take up construction of Vaikuntadhamams/ Crematoriums immediately without any further delay with the following components:

I. BASIC WORKS:

- a. burning platforms & akhri manzil (dimpudu kallam)
- b. Toilets for gents and ladies
- c. Wood storage room and ash storage lockers.

- d. office room
- e. Gate, Board and Cattle Trap, Fence/Compound wall, Boundary plantation, Plantation along pathways.
- f. Lighting

II.OTHER WORKS:

- a. Construction of compound Wall
- b. Laying of walk ways and roads,
- c. smruthivanam
- d. Parking area
- e. Seating Gallery
- 5. The Municipal Commissioners of all ULBs are directed to initially take up the Main works as mentioned above immediately by calling and finalizing tenders **within (15) days** and completion of all in saturation mode in 1-2 months from the date of issue of these circular instructions.
- 6. These will be reviewing the progress in the regular teleconferences. Inaction of the Municipal Commissioners will be viewed seriously.
